Executive Summary

This independent environmental audit (IEA) was conducted in accordance with Conditions A29 – A34 of consolidated development consent SSD 6966 dated 06 September 2024, as modified. The objective of the audit was to assess continual compliance with SSD 6966 during the operational phase of the Project. The audit period covers the period from 13 December 2024 to 29 May 2025. During the operational phase audits were carried out every six months in accordance with the approved audit schedule. This audit was the final audit for the project with building residences now occupied from early January 2025 and all conditions of consent related to pre-operation and operation assessed in this audit scope.

Consultation was undertaken as part of the audit process, DPHI were consulted and following auditor approval on 26 May 2025, City of Sydney consultation was undertaken via email on 27 May 2025 no reply has been received at the time of writing.

The site component of the audit was carried out on the 29 May 2025, the building was complete, and an occupation certificate had been issued by the PCA. The building was occupied by residents from early January 2025. Retail tenants have not occupied the building and no signage relating to retail tenants has been erected.

The findings of this audit are that the approved project is considered generally compliant with the SSD 6966 conditions.

No non-compliance issues were noted in relation to the Conditions of Approval (CoA). No observations or opportunities for improvement were identified.

The management and associated environmental programs in place were, within scope and were adequately applied on site by Lendlease and its contractors for the stage of the Project.

1 Introduction

1.1 Background

The Barangaroo redevelopment is a major urban renewal project located along the north-western edge of the Sydney Central Business District within the City of Sydney (Council) local government area. The 22-hectare site is bounded by Sydney Harbour to the north and west, Hickson Road to the east and King Street Wharf / Darling Harbour to the south. The Barangaroo site is divided into three redevelopment precincts, comprising of:

- Barangaroo Reserve.
- Barangaroo Central.
- Barangaroo South.

Barangaroo South development is bounded by Barangaroo Central to the north, King Street Wharf to the south, Hickson Road to the east and Sydney Harbour to the west as shown in Figure 1.1.

The precinct is divided into three construction stages:

- Stage 1A (Blocks 1, 2, 3 and X), including a mixture of mid and high-rise (from RL 25 up to RL 209) building envelopes for commercial towers, residential and retail buildings.

- Stage 1B (Blocks 4A and 4B), comprising three tower building envelopes (R4A, R4B and R5) for mixed residential use (heights ranging from RL 107 up to RL 250), Hickson Park public open space and Stage 1B shared basement.
- Stage 1C (Block Y) including the Crown Sydney Hotel Resort with a maximum height of RL 275.

On 3 October 2019, the Independent Planning Commission (the IPC) approved an SSD application (SSD 6966) for the construction, use and fit out of a 30-storey mixed-use development known as Building R5 within Barangaroo South Block 4B. The development has been modified five times since the original consent with the most recent being Modification 5 determined on 06 September 2024.


EMM Consulting (EMM) has been engaged by Lendlease and approved by DPHI to undertake independent environmental audit(s) (IEA) of the construction of the residential building known as R5. These independent environmental audits are required under conditions of approval (A29-A34) of the SSD 6966 project.

The audit program was originally submitted to the Planning Secretary in accordance with C8 and C9, the Secretary responded, requesting that the periodic audits be undertaken every six months. These conditions have been removed as a result of Mod 5 approval on 06 September 2024.

This Independent Environmental Audit (IEA) will be completed in accordance with Independent Audit – *Post Approval Requirements guideline May 2020* (DPIE) and undertaken in accordance with AS/NZS ISO 19011-2014. This IEA covers the period from 13 December 2024 to 29 May 2025, following the commencement of the operational phase.

The site and layout of the development is shown in Figure 1.2.

1.2 Audit team

The audit was conducted by EMM Consulting (EMM), approved lead auditor David Bone on 29 May 2025, see Appendix A. David Bone has signed the independent audit report declaration in Appendix B.

1.3 Audit objectives

The key objective of the IEA is to determine the project's compliance with SSD-6966 conditions of approval.

The independent audit requirements under SSD-6966 are detailed in the following subsections.

The IEA also determined compliance with the requirements of the Project's approved supporting documentation including management plans, monitoring, and reporting requirements. Finally, the IEA has assessed the overall effectiveness of environmental management at the Project through the site-based audit component.

1.4 Audit scope

Condition A29 of the SSD-6966 approvals requires audits to be undertaken in accordance with the Independent Audit Post Approval Requirements 2020 guidelines. These guidelines require a program of independent environmental audits be prepared for the development in accordance with AS/NZS ISO 19011-2014: Guidelines for Auditing Management Systems (Standards Australia, 2014) and submitted to the Planning Secretary for information.

The audit cycle has been undertaken every six months during construction and this audit is being undertaken within 26 weeks of the commencement of operation (occupation) and will be the last audit for the site.

In accordance with Condition A30:

Proposed independent auditors must be agreed to in writing by the Planning Secretary prior to the commencement of an Independent Audit.

The auditor approval by DPHI is contained in Appendix A. The auditor's report declaration of independence is in Appendix B.

1.5 Audit period

The audit period for this IEA is from 13 December 2024 to 29 May 2025.

2 Audit methodology

In accordance with Condition A29 the audit has been conducted in accordance with the IAPAR 2020 Guidelines and in reference to AS/NZS ISO 19011.2014- Guidelines for Auditing Management Systems. Provisional dates for ongoing inspections, reporting and notifications required for this independent audit are summarised below:

IEA #7 June 2025

- 29 May 2025 – undertake audit
- 24 June 2025 – submit draft report
- 29 July 2025 – proponent to load report and response to findings onto DPHI portal and project website

All audit reports and responses to be completed no later than 29 July 2025 in accordance with Condition A33, without seeking and extension of time from DPHI.

2.1 Selection and endorsement of audit team

This is an ‘independent’ audit; the auditor(s) must be endorsed by the Secretary of the Department of Planning Housing and Infrastructure (DPHI) prior to conducting the audit. A statement of the auditor’s independence from the project was submitted to DPHI and approval was obtained by Lendlease on 26 May 2025 prior to the audit commencing, see Appendix A.

2.2 Independent audit scope document

The scope of this IEA was developed in accordance with IAPAR 2020 guidelines, the conditions of approval are contained in the compliance matrix in Appendix D and are the basis for this audit.

The site operational activities and key operation documentation was reviewed on site, with further documentation requested following a site inspection on 29 May 2025 to ensure compliance is being implemented on site in accordance with the conditions and management plans.

2.3 Compliance evaluation

Compliance evaluation of the Project was undertaken firstly via a desktop review of publicity available documentation, a site inspection and key staff interviews and a request for information to review evidence of management plan implementation. A site visit was undertaken on 29 May 2025 to ensure that activities are being undertaken in accordance with the approved plans are that mitigation measures are being implemented on site in accordance with approved management plans. Site personnel were interviewed during the site inspection to ensure they understand their role in relation to the compliance requirements for the project.

2.4 Site interviews

Interviews were undertaken to ensure that the site personnel are aware of their roles and the requirements of the conditions.

Discussion points raised during the interviews:

- modifications to the development
- operation updates
- complaints and incidents and how they have been handled

- monitoring requirements and real time data
- daily / weekly inspections, plant inspection records
- site management
- incident reporting requirements.

2.5 Site inspection

On the 29 May 2025 a site inspection of the Project was undertaken. The auditor was escorted by Lendlease representatives during the inspection. Key site personnel that were involved in the site inspection:

- Jenny Chung – Lendlease Construction - Design Manager
- Bambi Mesa– Lendlease Development – Development Manager

The site inspection was undertaken on foot through the following areas:

- Basement, entry and carpark areas
- Plant and equipment rooms in the basement, roof and terrace levels
- Common areas
- Landscaping on the terrace and sky apartments
- External areas of the project including Hickson Park
- Publicly accessible areas surrounding the project – Barton St, Hickson Rd and Waterman’s Quay
- a perimeter walk around the remaining area focusing on public walkways and signage.

Appendix C includes photographs taken during the site inspection.

2.6 Consultation

Consultation was undertaken with DPHI prior to the audit to ensure that they were given the opportunity to raise concerns in relation to the project. Consultation letters / emails have been included in Appendix E at the time that the audit report was completed no additional feedback was received.

Additional consultation was undertaken with City of Sydney. A request for any additional scope requirements for the audit was sent to City of Sydney on 27 May 2025 along with a link to the proponent’s website to assist with identification of the project. No response has been received at the date of writing.

2.7 Compliance status description

The audit has been undertaken in consideration of the following compliance status descriptors, which is consistent with specific advice from DPHI and the IAPAR 2020 guidelines:

- **Compliant** - the auditor has collected sufficient verifiable evidence to demonstrate that all elements of the requirement have been complied with within the scope of the audit.
- **Non-compliant** - the auditor has determined that one or more specific elements of the conditions or requirements have not been complied with within the scope of the audit.

- **Not triggered** - a requirement has an activation or timing trigger that has not been met at the time when the audit is undertaken, therefore an assessment of compliance is not relevant.

In addition to the compliance status descriptors, the auditor may provide observations and notes, identifying any opportunities for improvement, as they see fit in relation to any compliance requirement or any other aspect of the project.

3 Audit findings

3.1 Approvals and documents audited

The following documents were reviewed to assess compliance against relevant project approval conditions and the operational performance and effectiveness of environmental management measures implemented during the audit period:

- SSD 6966 Consolidated Consent (Mod 5 – 06 September 2024)
- Occupation Certificate (OC) CFT-647704 issued by McKenzie Group
- DA D/2023/534 – Signage for retail spaces
- Community Consultation Strategy Rev 2- Building R5 November 2021
- Waste Management Sub Plan Rev 25– June 2024
- Water & Stormwater Management Sub Plan - January 2022 Rev 18
- Construction Noise & Vibration Management Plan Rev 29 – July 2024
- One Sydney Harbour Environment, Health Safety Management Plan – September 2021
- Air Quality and Odour Management Sub Plan - Rev 22 Issue 3.0 – January 2022
- Condition B3,4 External Walls and Cladding statement of compliance
- Condition B11, E34 – INSW certification of public domain works and defects
- Condition B13 - R5 Lighting and Light Spill Report statement of compliance, Sydney Observatory acceptance letter
- Condition B14, E5, E10, E22 – Pre-construction and post construction dilapidation reports
- Condition B15 Structural Engineers reports of compliance

3.2 Compliance performance

The IEA looked at the compliance requirements for the project.

A total of 60 items were identified from the 226 conditions which compliance was required to be determined during the audit. 166 items were found to be closed and not triggered for this operational phase of the audit. These were comprised of:

- SSD 6966 Conditions of Approval
- Approved Construction Environmental Management Plan (CEMP) and sub plans
- Of the 60 conditions triggered for this audit, all 60 were identified to be compliant.

- No Non-compliance were raised
- Two (2) recommendations were made in relation to ongoing audits and reporting.

Lendlease personnel were able to answer the questions associated with the development approval and documentation and data to support compliance was ordered and easily accessible upon request. The site was in a clean and ordered state and considered generally compliant against all conditions.

Refer to Appendix D for the details of the conditions that apply to the project.

3.3 Summary of agency notices, orders, penalty notices or prosecutions

There were no notices, orders, penalty notices or prosecutions reported to the auditors or identified from searches undertaken during the audit period.

3.4 Previous audit areas of non-compliance/improvement recommendations

There were no observations noted from the previous audit.

All non-conformances and observations from previous audits are closed.

3.5 EMP, subplans and compliance documents

The Environmental Management Plans and sub plans have been developed in accordance with the conditions of consent. Compliance documentation has been established and shows correct implementation in accordance with the EMP and sub plan requirements.

All plans are up to date for the stage of the development. Details on the documents reviewed in relation to these documents is contained in Appendix D. The site inspection noted the following in relation to compliance with these plans:

- Signage clearly displayed at all entries to the site and in accordance with approvals.
- Pedestrian and cyclist pathways were unobstructed and clearly signposted.
- Waste separation is occurring on site and all wastes were appropriately stored and managed for the building.
- Landscaping has been installed generally in accordance with the approved plans with all plants and finishes noted to be in good condition at the time of the audit.
- Furniture in open space areas was in accordance with approval requirements and has been approved as required.
- Operational management plans are approved and being implemented
- Plant and machinery has been certified as meeting requirements and no issues were noted
- Car parking allocations were in place and in use at the time of the audit

3.6 Environmental performance

The site was well organised, site personnel were aware of the environmental requirements under the conditions of consent and how they related to their role on the project. Compliance with the requirements in the CoA is undertaken regularly as part of the compliance process and is well organised and easily retrievable.

Site managers are knowledgeable of all requirements in the CoA and have active measures in place to monitor compliance and performance across the site.

3.7 Consultation outcomes

DPHI was advised of the scope of the audit and requested the auditor approval. Additional consultation was undertaken with City of Sydney. No response was received at the time of writing. A summary of consultation undertaken can be found in Appendix E.

3.8 Complaints

No complaints were received during the six-month audit period.

DPHI did not raise any issues with regard to complaints or issues with the project which required further investigation.

3.9 Incidents

No reportable incidents have been recorded during the audit period.

3.10 Actual verses predicted environmental impacts

The project is being managed in accordance with the approved environmental management plans developed to mitigate environmental impacts. At this stage of the development the project is considered to be compliant with predicted impacts.

The building is now occupied, with practical completion achieved by end of 2024. All aspects of the building design, location and visual features have been certified by the PCA and have been undertaken in accordance with the CoA and predictions of the approval documents. The audit inspection did not identify any issues with environmental impacts which were not in accordance with the approval documents.

3.11 Site interviews

All site personnel were aware of their environmental requirements for their roles on site. Section 2.4 above lists the site personnel involved in the site interviews.

3.12 Site inspection

The focus of the inspection was to determine the implementation of operational measures contained in approved plans. Visual inspection was undertaken to ensure compliance with the conditions of approval. No issues were noted during the site inspection.

4 Recommendation

4.1 Non-compliance

No non-compliance was noted in relation to Condition of Approval (CoA) during the audit.

4.2 Opportunities for improvement and recommendations

No opportunities were made as part of this audit, two (2) recommendations were made:

- SSD 6966 REC#1 – CoA A28 – It is recommended that a request to DPHI should be made for the cessation of compliance reporting as operational compliance has been achieved by this audit.
- SSD 6966 REC#2 – CoA A29-A34 It is recommended that a request be made to DPHI for removal of the three year audit requirement (as per A34) under the Independent Audit - Post Approval Requirements May 2020 (DPIE).

5 Conclusion

This last audit considered at a total of 60 conditions of approval which were triggered for this audit for the operations of 30-storey mixed-use development known as SSD 6966 - Building R5 within Barangaroo South Block 4B. Construction commenced at the site in April 2022, and was completed in November 2024, the operations commenced from January 2025. This is the seventh and final IEA undertaken for the Project.

Of the 226 conditions, 166 were identified as not triggered as they relate predominately to pre-occupation requirements, pre-construction and during construction aspects of the property, of the remaining operational conditions triggered, all were found to be compliant.

The total Barangaroo One Sydney Harbour project has several separate approvals across three buildings, each building also has several stages. In addition, there are five approved modifications to SSD 6966 that have added to the complexity of the project requirements. Lendlease has been able to address these requirements through development of detailed compliance tracking against construction and occupation certificates, CoA and separate DA's.

Based on the review of the documentation provided, and the site inspection that was undertaken on the 29 May 2025, the Project (SSD-6966) was considered generally compliant with the conditions of approval.

EMM would like to take the opportunity to thank the Lendlease's representatives involved in the audit process, we appreciate that the project team was acutely aware of the environmental conditions, approvals and the management plans and sub plans for the project, making the audit process run smoothly.



Regular interface meetings are held by the site teams and these meeting agendas and minutes are reviewed as part of the audit. Where DPHI require any other consultation to occur or consider that the audit should have any key areas of focus, the scope will be adjusted to include these requests.
